Prevention

Keep/Store away from clothing/combustible materials
Take any precaution to avoid mixing with combustibles
Keep only in original container
Do not breathe dust/fumes/gas/mist/vapours/spray
Do not get in eyes, on skin, or on clothing

Response

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting

Engineering Measures

(Refer to manufacturer/supplier for information) gloves are suitable for the task: Chemical compatibility, Dexterity, Operational conditions, User susceptibility, e.g. sensitisation effects, also take into consideration the specific local conditions under which the product is used, such as the danger of cuts, abrasion. gloves with care avoiding skin contamination.

Respiratory Protection
